Motions and resolutions from the floor MUST be presented in writing.

INTRODUCTION OF NEW BUSINESS – This is an item on the docket placed there to provide an opportunity for any member or commissioner to introduce matters that might not be a part of a Committee's report. This is your method of docketing a matter that you feel is important to the business of the Presbytery. Under the procedure, this new business will be referred to the Committee having cognizance over this matter. If at all possible, prior to the start of the meeting please give the Stated Clerk a summary of your item for new business so he/she can advise the Moderator.

**REMINDER TO CHURCHES** – If your elected commissioner or alternate is unable to attend a presbytery meeting, the Session may appoint another elder, either currently serving on the session or not, to serve as commissioner for that meeting. ALL visitors attending from your church need to either pre-register or sign in at the registration table at the meeting.

HOW TO PRE-REGISTER – Go to <u>www.psei.net</u>. Under the banner near the top of the page you will see *ministries* listed – put your cursor on that tab. On the drop-down menu, click on *Presbytery Meetings*. Here you will find the entire list of meeting documents. Read and print the ones you may want for the meeting.

- PLEASE NOTE: If you need child care, please give us the name, age and allergies or special needs for each child.

Our office will receive notification of your pre-registration. <u>If you are going to be absent, you still need to let us</u> know by utilizing this form.

### **The Community Prays Together**

Teach us to pray, they asked him. And so he did, teaching them to pray for their needs, for the needs of others, and for the needs of all creation. 


## (Psalm 133)



## 2017 Narrative Budget


The presbytery is made up of all the pastors and an equal number of representatives from each PCUSA congregation within our borders. The presbytery elects several committees to assume specific responsibilities and to recommend actions to the presbytery. In addition to the members who serve as volunteer committee members, the presbytery also calls/employs paid staff – currently two full-time (Director of Camp Carew and PSEI Administrative Assistant) and four part-time positions (Presbyter for Congregational Care, Stated Clerk, PSEI Secretary and Treasurer).


The presbytery's overall function is to be a "connector" in our connectional denomination. With 85 central and southeastern Illinois congregations ranging geographically from Paxton to Metropolis and the Wabash river to Chester; in size from fewer than ten members to hundreds; in age, from congregations over 200 years old to less than 10 years old, there are many diverse needs. Churches by their nature are great responders to the needs of those in their communities. By supporting the presbytery our congregations are also responders to the needs of fellow southeastern Illinois PCUSA churches. The presbytery serves as a "connector" between the PCUSA and our member congregations.

The General Council, elected by the presbytery members shapes the overall direction of the work of the presbytery. Our two part-time professional staff (Presbyter for Congregational Care, and Stated Clerk) in partnership with the Committee on Ministry are in constant, personal contact with the sessions, pastors, clerks and commissioners of PSEI congregations. The need may be for problem solving, conflict resolution, pastor searches or something entirely different. The PCC and the Stated Clerk are equipped through training and experience to bring insight and offer solutions to a session's needs. The Committee on Preparation for Ministry works with potential pastors and sessions. The Camp and Conference Board of Directors oversees the work of Camp Carew in partnership with the General Council and the whole presbytery.

#### Where we find ourselves


The general membership trend of the Presbytery is like that of many mainline denominations and a growing number of non-denominational churches - declining. While it is true that some of the congregations have a growing number of people in worship their membership numbers don't show an increase because holding membership in a congregation does not have the same value that it once did in our society. In addition, with six congregation dismissals (and one in process) and six congregation closures while only have one new congregation in the last few years you will see a decidedly downward direction in our membership numbers. The result is that presbytery has fewer resources available for the churches to call upon for help.





Six years ago the Presbytery voted to engage in a daring experiment to see if funding for a full-time Camp Director would increase the sustainability and ministry of Camp Carew. The funds to cover the cost of this experiment were to come from the congregations' mission giving. In 2015, the Presbytery voted to continue the experiment for two more years. This has meant that the Presbytery substantially increased its overall giving toward the expenses of Camp Carew as it paid for the salary and benefits of the Camp Carew Director while continuing to cover the operating expenses for the camp's Board of Directors (meetings, mileage, meals). However, as congregations struggled to meet their own expenses the presbytery saw a decrease in mission giving. During the first five years of the experiment the majority, and then more than all of the mission funding, went to cover the Director's package and a declining amount was available to fund the camps' program expenses. Our giving toward camp program support declined from \$20,000 to \$6,000 per year in that time. Now we are in the season where the financial commitment to Camp Carew and the Director's package will exceed the congregations' mission giving.

Camp Carew continues to receive funds from the Presbyterian Foundation, both from funds set up by individual donors and from the Camp Carew Foundation (which was established by the presbytery with over a quarter of a millions dollars in principal). Additionally, Camp Carew receives a number of generous donations of time and talent directly from congregations. In spite of all that effort, attendance at camp is following the same trend as membership and congregation numbers.



#### The Bottom Line

The Presbytery of Southeastern Illinois has specific responsibilities it <u>must</u> fulfill, regardless of the number of congregations and members that are in its midst. We do <u>not</u> have the option to "close up shop" and cease to be a presbytery. The options before us are to:

- Increase income
- Decrease expenses
- Share expenses for some functions with another presbytery
- Dissolve as a presbytery and join with another presbytery, thereby increasing our already large geographic borders
- Pursue other creative options, like dividing into smaller presbyteries that can be staffed by one part-time person.


#### Income

- 1. Per Capita giving Annually, each congregation is asked to pay an amount per member to support the work of the presbytery, the Synod of Lincoln Trails and the General Assembly. Currently that rate is \$40. While it is true that per capita giving for congregations is not mandated, every presbytery is mandated to submit the full payment for each congregation to the synod and the General Assembly regardless of the amounts submitted by its member congregations. For 2017, presbytery plans to collect \$257,906, of which \$183,521 will be used for presbytery expenses. Options for increasing revenue are limited to increasing per capita from the current \$40, seeking 100% participation from congregations and growing congregational membership.
- 2. **Mission Giving** In addition to per capita, each congregation has the opportunity to include presbytery in their mission giving. Currently, PSEI's mission focus is Camp Carew in 2017 we plan to spend 102% of the mission money collected to support Camp Carew.
- 3. Other Income The presbytery is the beneficiary of a long-standing trust that provides some investment income (\$10,500 expected in 2017) to help with operating costs. Options to increase other income are to pursue a riskier, potentially higher return investment strategy, pursuing a planned giving program.
- 4. **Synod Funds** We have been fortunate to receive grants from the Synod of Lincoln Trails for Pastoral support and Enrichment and for Congregational Mission Grants. This has allowed us

- to disburse \$133,000 to help our pastors and congregations. The funds were restricted to these purposes.
- 5. Designated Reserves This includes \$50,000 that was set aside for a three-year commitment to Mission Discovery a program to assist congregations in transition or in need of redevelopment. This money was set aside to pay for the costs associated with Holy Cow Church Assessment Toom, the interpreters and their expenses, for the expenses associated with Appreciative Inquiry leaders, and for training for all of these programs. The designation of these funds expires at the end of this year and the remaining funds will become available again for operating expenses.

## **Expenses:**

- 1. **Mission Giving** Camp Carew in 2017 we plan to give 102% of our available mission funds to Camp Carew. The presbytery currently provides all of the compensation for the camp director (one of the 2 full-time positions) and \$6,000 of undesignated camp program support. **Total direct expenditure \$57,150**.
- 2. **Denominational support** mandated per capita assessed by and paid to the General Assembly and Synod of Lincoln Trail. **Total Expense \$74,386**
- 3. Congregational outreach we make both Bill and Cindy (both part-time employees) available to meet the needs of our members. In addition, we cover the expenses of the volunteer committee members who work with congregations. Total Expense \$167,023
- 4. **Connective services** presbytery provides Brenda, Marsha and Paul (one full-time, two part-time) to help congregations with administrative needs, ranging from filing annual reports to maintaining membership directories and facilitating connections. Brenda and Marsha work from a rented space in Decatur. **Total Expense \$129,401**
- 5. **Administrative committees** expenses of volunteer committees who oversee the operation of the presbytery. **Total Expense \$9,300**

All minutes of the Administrative Commission will be submitted to and received by the Presbytery upon the completion of their work and will thereby become a part of the Presbytery minutes.

Rationale – The Newman Shaw Memorial congregation sold its building a number of years ago and conducted worship for a while in a building in an area cemetery. Regular worship ceased some time ago. A few years ago it came to the attention of COM that the congregation wasn't having session meetings with a moderator, nor worshipping or receiving communion quarterly. The members were worshipping at other churches. The leaders of the church met primarily to distribute funds when needs arose in the local community. Teaching Elder Cindy Shepherd became their moderator and sought to have quarterly session meetings which included worship and the Lord's Supper. It is with her advice that we seek to gain approval for this AC. She assures us that the remaining members of the church are ready for this, are expecting it and have distributed most of their remaining funds.

#### Romine Prairie United Presbyterian Church, Kell, IL Administrative Commission Report

Presbytery of Southeastern Illinois Stated Meeting
August 18, 2016
First Presbyterian Church, Danville, IL

#### History

On January 27, 2015, the Romine Prairie session moderator Teaching Elder, Beau Brown contacted Presbytery leadership to notify us that the session expressed interest in being dismissed to the Evangelical Presbyterian Church. During the month of February people were recruited to serve on a Listening Team. Once they were all recruited it was decided to wait until after Easter (April 5<sup>th</sup>) ds to set a meeting date with the Romine Prairie congregation.

On Saturday, June 20, 2015 the appointed Listening Team met with 12 people, including their temporary pastor Jerry Fields. During the meeting members expressed a variety of concerns regarding the PC(USA) including the overture passed by the 221<sup>st</sup> General Assembly seeking to redefine marriage, the denominational stance on abortion options, the variety of theological viewpoints found within the denomination, etc. The Listening Team recommended that an Administrative Commission be appointed to work towards dismissal and at the Presbytery meeting held on August 20, 2015, the following five people were elected to serve: Teaching Elders Kerry Bean, Cobden; Rachel Helgeson, Mt. Vernon; and Ruling Elders Janet Proctor, Golconda; Granger Odum, Marion; and Mac Butler, Eldorado who was appointed Moderator.

The members of the Romine Prairie congregation were polled concerning possible meeting dates and they selected three weekend days in October. On Wednesday, September 23, 2015 the Administrative Commission had an organizational conference call and sought to select a meeting date with the congregation. On October 10, 2015 there was a meeting with the Romine Prairie congregation. They were given the list of items they would need to complete in order to be dismissed to the EPC. It was reviewed in great detail. There were two areas of concern – 2 endowments through the Presbyterian Foundation (one for the cemetery and one for the congregation) and the lack of title documentation available. It was agreed that goal would be to complete the work in time for the February 2016 Stated Meeting.

At the end of October 2015 letters were sent to all active members of the Romine Prairie congregation explaining the procedure if they wished to stay within the PC(USA).

On November 3, 2015 the Presbytery received a letter notifying us that the Romine Prairie congregation was the recipient of two endowments of approximately \$52,000 each and that there were contingent beneficiaries (not the Presbytery) who would begin receiving the funds once the congregation was dismissed. It had been the hope of the Administrative Commission that the Presbytery would be the contingent beneficiary of at least the cemetery endowment so that they could turn that back over to the congregation after dismissal so that they could maintain the cemetery. There is no expressed desire on the part of the Presbytery to take possession of the cemetery nor to be responsible for its maintenance. There was nothing that the Administrative Commission nor the Presbytery could do to prevent the transfer of the endowments to the contingent beneficiaries.

On November 6, 2015 AC Moderator Mac Butler contacted congregation member Mr. Granville and asked how they were progressing with their to-do list. They weren't happy with the expense of an appraisal and were hesitant to use the insurance number. They didn't know about the contingent beneficiaries for the Foundation money and Mr. Granville understandably found the news troubling. He indicated that they would be ready for another meeting.

After the holidays AC Moderator Mac Butler reached out to Mr. Granville and he explained that they were trying to find some way to retain the Presbyterian Foundation funds. Until that issue was resolved they were not ready to proceed. On February 3, 2016, the AC was informed that the Romine Prairie congregation had accepted the fact that they would lose the funds from the Presbyterian Foundation and were beginning the process with the EPC and would like to proceed.

On February 11, 2016, there was a conference call for the Administrative Commission where it was confirmed that the congregation was not going to be ready for dismissal in time for the Presbytery meeting but that they were ready to proceed once more. It was determined that we needed three years of financials and annual reports and to assess the progress of being received by the EPC. Some of the financial information was received on February 26 and the rest was received on March 17, 2016.

By March 25, the AC had received word that the process of being received by the EPC had not progressed and the Romine Prairie congregation would not be received at the April Stated meeting of the EPC's Rivers and Lakes Presbytery. A conference call was scheduled with the AC just to check in with each other and explore dates for meeting with the congregation. In the middle of April Mr. Granville indicated that a meeting date of May 1<sup>st</sup> would work.

On May 1, 2016 a meeting was held with the Romine Prairie congregation and the AC. Upon arrival at the meeting it was quickly determined that no progress had been made on the to-do list for dismissal. The necessity to complete these steps was again reviewed. Additionally, the intent of the trust clause, to ensure that there is a PC(USA) presence still in that geographic area or within a reasonable distance was reviewed. Dismissal of the congregation located in Kell would mean that there was no PC(USA) presence between Mt. Vernon and Salem along IL-Rt. 37 on the North/South axis (23 miles) and none between Centralia, IL and Olney on the East/West axis (70 miles). No progress was made at this meeting and the tone was contentious. A meeting was scheduled for July 10<sup>th</sup>, but Mr. Granville called to say that they needed to reschedule.

On July 31, 2016 the Administrative Commission met with the congregation members. Also in attendance was Patricia Miller, a lawyer who was a Ruling Elder and Clerk for recently dismissed congregation in Herrin, IL. They had recently been examined by the EPC and will be accepted at the end of September pending our dismissal. They reported on the status of the items on the to-do list and indicated which had been completed and which Patricia Miller will handle and which will be handled by the EPC. When it came to negotiating the terms of dismissal there was a reluctant offer of \$1000. After AC members expressed their doubts that this would be approved by the Presbytery they made a final offer of \$1500. The necessity of obtaining Presbytery approval in order to be dismissed was explained to them. They were urged to be at

the meeting to speak on their own behalf because the AC members believed that this amount would not be approved by the Presbytery. Mr. Granville indicated that their need to speak wouldn't be necessary.

#### Actions taken by the Romine Prairie United Presbyterian Congregation

#### 1. Change of name:

Their current name is Romine Prairie United Presbyterian Church, Kell, IL. Their proposed new name would be The Romine Prairie Presbyterian Church, Kell, IL.

- 2. Secure a valuation of the church building. see attached insurance document Please note that this is not replacement cost insurance. Also note that this does not include 3 acres of land located at the corner of IL Rt. 37 and IL Rt. 161. Additionally, this does not include a valuation of the cemetery. There are only a handful of plots available for sale at \$100 per plot and no one would buy a cemetery so the AC concurs that the cemetery should not be considered in the valuation.
- 3. Removal of PCUSA emblems They have removed the symbol from their outdoor sign and inside their building.
- **4.** Church records to be read: The Session minutes and rolls and registers were read through 2012. They will be read again close to the September 2016 dismissal.
- 5. Church records turned over to the Presbytery: They have been informed that records must be turned over to PSEI who will send them to the Presbyterian Historical Society. They have already made their own paper and electronic copy of the records.

#### 6. Legal and Liability Limiting Actions

The congregation understands that by leaving the denomination they will have to forfeit the funds held with the Presbyterian Foundation. They have no loans or other encumbrances or other sources of incomes (such as a farm or oil well, etc.), the following items are a list of items that need to be completed or in process in order to be released from the PC(USA) and dismissed to the Evangelical Presbyterian Church. The following items need to be complete in order to limit the liability of the Presbytery of Southeastern Illinois' for the church that will formerly be known as Romine Prairie United Presbyterian Church, Kell, IL.

- Change the name of the Church (see above)
- Secure a new Employer Identification Number using the new name
- Secure a letter of tax exemption through the Evangelical Presbyterian Church's 501c3.
- Notify insurance company of the change in name and denominational affiliation. This is particularly important for the Board of Directors Liability Insurance.
- Notify all vendors of the denomination affiliation change and new name.
- Give banks, utilities, vendors new 501c3 letter and new name and inform them of change in denominational affiliation.
- Change the title for property (church and cemetery).
- Change the by-laws to reflect the new denominational affiliation.
- Change the name and file new copy of 501c3 letter with any licensing companies/contracts like CCLI, etc.
- Publish any and all legal notices as may be required by law.

#### Rationale:

First, after reflection (on the Listening Team report, the relationships formed in this process, etc.) it is the belief of the Administrative Commission that the Romine Prairie United Presbyterian Church, Kell, IL, is called to leave the Presbyterian Church (USA) in order to affiliate with a denomination more in line with their theological and Biblical beliefs.

Second, the Administrative Commission's work with the Romine Prairie congregation was guided by the following principles: consistency, pastoral responsibility, gracious witness, and openness and transparency.

"In the recent General Assembly Permanent Judicial Commission (GAPJC) case, <u>Tom v. Pby of San Francisco</u>, the GAPJC authoritatively interpreted how the Trust Clause found in the Book of Order at G-4.0203 interacts with Gracious Dismissal Policies.

- 2. Believing that trying to exercise this responsibility and power through litigation is deadly to the cause of Christ, impacting the local church, other parts of the Body of Christ and ecumenical relationships, and our witness to Christ in the world around us, [the General Assembly] urges [congregations considering leaving the denomination,] presbyteries[,] and synods to implement a process using the following principles:
- Consistency: The local authority delegated to presbyteries is guided and shaped by our shared faith, service, and witness to Jesus Christ.
- Pastoral Responsibility: The requirement in G-11.0103i to consult with the members of a church seeking dismissal highlights the presbytery's pastoral responsibility, which must not be submerged beneath other responsibilities.
- Accountability: For a governing body, accountability rightly dictates fiduciary and connectional concerns, raising general issues of property (G-8.0000) and specific issues of schism within a congregation (G-8.0600). But, full accountability also requires preeminent concern with "caring for the flock."
- Gracious Witness: It is our belief that Scripture and the Holy Spirit require a gracious witness from us rather than a harsh legalism.
- Openness and Transparency: Early, open communication and transparency about principles and process of dismissal necessarily serve truth, order, and goodness, and work against seeking civil litigation as a solution.
- \*This case was issued prior to the approval of a major restructuring of the Form of Government.

Third, the insured value (not at replacement cost) of the church building is \$283, 400. This does not include the 3-acre lot at the corner of IL Rt. 37 and IL Rt. 161. While the building appears to be in good condition, the congregation members have indicated that they have nearly \$30,000 in future maintenance costs. The Administrative Commission believes it would be difficult to find a buyer for the church building at or even near that value. The costs associated with maintaining the vacant buildings until it is sold should be considered – maintenance, security, utilities, etc.

Fourth, as indicated above the cemetery has no real value for sale. They have lost the Presbyterian Foundation funds that would help with the upkeep of the cemetery, but they do have

healthy perpetual care funds for the cemetery. It is recommended that the Presbytery not consider these (funds & cemetery) in the valuation of the property for trust clause purposes.

Fifth, since virtually the entire active membership attended every meeting with the Listening Team and the Administrative Commission and all have expressed their commitment to leave the denomination, it was felt that dividing the congregation would not be feasible nor could the Presbytery use the facility for a New Church Development.

Sixth, the Romine Prairie congregation has expressed a history of dissatisfaction with the PC(USA) as they met with the Administrative Commission. They expressed repeatedly that the PC(USA) has left them. Members of the congregation expressed their belief that negotiations for terms of dismissal in order to fulfill the Presbytery's fiduciary responsibility on behalf of the denomination's trust clause is "extortion".

Seventh, despite their differences with the Presbytery and the PC(USA), the Romine congregation has been generous in their support of missions with connections to the Presbytery and has always paid their per capita in full.

Finally, believing that the Presbytery and the body of Christ would not be furthered by litigation nor possessing an empty building, the Administrative Commission recommends dismissal to the Rivers and Lakes Presbytery of the Evangelical Presbyterian Church. However, the Administrative Commission feels that while the congregation is small in active numbers, the offer of \$1500 will cover the per capita costs due in 2017 and 2018 in the following amounts and only leave a very small amount after meeting their obligations:

\$380 to be used at General Council's discretion. This very small amount is all that is left to account for our fiduciary responsibility (the trust clause) to the denomination to ensure that there will a continuing PC(USA) presence in that area.

The Administrative Commission would appreciate the Presbytery's advice in how to proceed in light of the fact that the AC feels that accepting Romine Prairie's final offer would not rise to the level of meeting our fiduciary responsibilities to the trust clause of the PC(USA).

Upon approval of terms of dismissal the following motions will also need to be approved:

• That the Romine Prairie United Presbyterian Church, Kell, Illinois, be dismissed from the Presbyterian Church (USA) and the Presbytery of Southeastern Illinois pending being received by Evangelical Presbyterian Church and the Rivers and Lakes Presbytery at their

upcoming meeting on September 24, 2016. To the extent lawful, all property, assets, membership, rights, privileges, responsibilities and liabilities will be transferred to the newly formed Not for Profit Church which will be known as The Romine Prairie Presbyterian Church and will be under the jurisdiction of the Evangelical Presbyterian Church conditioned upon the actions of Item 6 occurring by the dates specified conditioned upon accuracy of all representations and assurances, including those listed in Item 6 above.

- Authorize the Stated Clerk, Rev. Cynthia Bean and/or Treasurer Paul Saegesser, officers
  of the Presbytery of Southeastern Illinois to take any and all actions necessary to fulfill
  intent and purpose of this action, including signing deeds, contracts and other required
  legal documents.
- That \$1120 of the amount received from the Romine Prairie congregation as a part of the dismissal be designated to cover the cost of per capita due on behalf of the congregation to the General Assembly, Synod and Presbytery.
- That the Romine Prairie Administrative Commission be dismissed with thanks.

#### James Potts – Statement 1

1. A statement of your understanding of Christian Vocation in the Reformed Tradition and how it relates to your own sense of call.

My understanding of Christian Vocation is when your passions and your job meet. I have a passion to learn and study the Bible, to help people, to be an example of Christ's love, to embrace all children of God regardless of age, race, gender, sexuality, etc...

I know I have been called by God to be a pastor. This call has continuously been affirmed and validated by God throughout the past few years. I believe it is my call to serve a local church, to study and teach the Scriptures, to embrace all children of God. To support in times of loss. To guide in times of confusion. To celebrate in times of joy.

My sense of call began when I was in middle school. I had a strong sense of God calling me to youth ministry. Over time that grew to a broader sense of ministry. When I began seminary I knew I was called to parish ministry, but in what aspect I was not completely sure, but I was open. During my second year of seminary, when I was completing my field education, my sense of call began to become more clear.

During this year I had the opportunity to experience all aspects of ministry in a local church. I wrote liturgy, I preached, I taught confirmation and adult education classes, I visited elderly members who were not able to get to church every Sunday, I was a youth group advisor, and participated in leading youth retreats. I even sat in on budget and council (this was a union PCUSA/UCC church) meetings. I worked closely with each of the pastors in order that I was able to have a full experience of ministry.

This year provided me with a clear sense of call to pastoral ministry. When I started, I thought I would fail or would not be good at anything. But as the year progressed, my confidence grew and I was beginning to find my voice as a teacher, preacher, and pastor. Youth would come to me and ask me to pray with them regarding college applications/decisions. Children would come to me and ask me to help them with their Boy Scout projects or to ask me to pray with them because their dog or cat died. Adults would come to me and tell me how much they appreciated my words from a prayer I prayed in service or that my sermon could not have come at a more perfect time. I am not saying these things as a way to brag, but to reinforce for myself the affirmation of my calling to this work.

While I know it is going to be difficult at times, I know I will be able to do this work because it is the work which God has called me to do.

Questions for Enrollment as Candidate

July 2016

1. A statement of your understanding of Christian Vocation in the Reformed Tradition and how it relates to your own sense of call.

I affirm the statement found in our denomination's Book of Order: "For Christians, work and worship cannot be separated" (W-5.6003). As described earlier in that section, the Reformed Tradition embraces the belief that God calls us to faith, discipleship, and service. We respond to this call by worshipping in a community, by ministering to the needs of the community/world, and by honoring and serving God and neighbor with the actions of our lives (W-5.6001-6002). I understand and strive to embody this tradition in the following ways:

Grace is a gift given to us by a loving and merciful God. There is nothing we can do to earn this grace, nor to earn more (or less) of it. If we believe in our own forgivenness (through Christ), we are forgiven. Although there are no works we may do to earn this divine gift, our true acceptance of it generates within us seeds of gratitude and a desire to extend that love and mercy to others. Once planted, these seeds depend upon a symbiotic relationship between our work/daily living and our faith/worship. By nurturing our faith-life, we cultivate these fertile seeds within us, so that the various aspects of our daily lives—our actions, our attitudes, our words, and our relationships, from our households, to our occupations, to our communities—are acts of gratitude, service, and, ultimately, worship.

Because I am in tune with the many gifts God has given me – not only through divine grace, but also in my places of privilege – I am compelled to honor and worship God in a spirit of gratitude and service in all areas of my life. As I am at least in part a product of my culture and context, it is not unusual that I, a young American adult in the 21st century, locate a large part of my identity in my occupation. I have learned from experience that I cannot work in a place or for a person/persons whose values are not in line with my own. For example, in an environment or organization in which financial interests are held higher than the interests of the people involved (those serving and those served), I am unable to commit my time, talent, and energy. 



#### "The Hope in Our Calling"

Some General Assemblies make their mark. Others make history. The 222nd General Assembly (2016) made so much history that it will long be remembered as one of the most significant in the life of the Presbyterian Church (U.S.A.).



Newly elected General Assembly Stated Clerk J. Herbert Nelson-who made history by becoming the first African American elected to the denomination's top ecclesiastical post—perfectly reflected the assembly's theme, "The Hope in Our Calling": "The Presbyterian Church is not dying, but I believe we are reforming. To think only of the survival of the church means our aim is too low."

This assembly, in addition to electing Nelson, produced almost too many Kairos moments to mention: electing the first Co-Moderators in history and a two-woman moderatorial team for the first time: added the Confession of Belhar to the denomination's Book of Confessions; approved a

protect from harm the children and youth in our midst: and created an administrative commission to tend to structural issues in the church and a "vision team" to establish and reclaim the church's identity.

And the assembly accomplished its work in a spirit of collaboration and trust not seen in recent, far more contentious assemblies. Less than a handful of assembly committee recommendations were overturned in plenary session and debates, while passionate, didn't exhibit the rancor of previous assemblies.

At the end of the day, commissioners and advisory delegates seemed determined to heed the parting advice of retiring General Assembly Stated Clerk Gradye Parsons: "Just don't give up on this church---DON'T!!!"




History2: Two women elected Co-Moderators

History was made in at least two ways Saturday night when the 222nd General Assembly (2016) elected its first Co-Moderators and its first all-women moderatorial ticket. The Reverend Denise new Directory for Worship; took steps to Presbytery of SE Illinois Page 55 of Anderson, a paster from the Rigisbytes by

of National Capital, and the Reverend Jan Edmiston, associate executive presbyter for the Presbytery of Chicago, won a first ballot victory over Ruling Elder David Parker of the Presbytery of Salem and the Reverend Adan Mairena, a pastor in the Presbytery of Philadelphia. The margin was 76 percent to 24 percent.

Anderson and Edmiston are the first Co-Moderators elected since the 221st General Assembly (2014) approved a standing rules change to allow that arrangement. They are also the first two-woman ticket to moderate a General Assembly.

"We want you to remember this number: 104," Anderson told the assembly. "That is the number of weeks between now and the next General Assembly. We pledge to show respect and compassion—listening is more than waiting to talk."

J. Herbert Nelson was overwhelmingly elected General Assembly Stated Clerk in an historic vote, becoming the first black man selected as the top ecclesial officer of the nation's largest Reformed body, a largely white denomination.

Commissioners selected Nelson over



David M. Baker, stated clerk and communications director of the Presbytery of Tampa Bay, by a 447-112 margin. Nelson, director of the PC(USA)'s Office of Public Witness, succeeds Gradye Parsons, who is retiring after eight years as Stated Clerk.

He was installed immediately after his election and will begin his duties August 1.


"This is a powerful day, a powerful day in my life and for many people of color who did not envision the possibility of this ever happening," Nelson told the assembly, adding he asked only one thing of commissioners: "Pray for me and work with me-and not on me-and we'll get some things done in the name of the Lord."

#### Belhar added to Book of Confessions

Thirty years after it was birthed in South Africa by the Dutch Reformed Mission Church (DRMC) during its battle against apartheid, the Confession of Belhar has been included in the Book of Confessions of the PC(USA).

After a four-year-long process of study and votes by the 221st General Assembly (2014) and then the 171 presbyteries, the assembly voted overwhelmingly (540-33)

to make Belhar the denomination's 12th recognized confession and the first originating in the global south. It focuses on the themes of justice, unity, and reconciliation, which are just as important today in the U.S. as they were thirty years ago, when Belhar was approved by the DRMC in the midst of South Africa's apartheid regime.



#### A new Directory for Worship

A slimmer, less restrictive Directory for Worship for the Presbyterian Church (U.S.A.) was overwhelming approved June 22. The directory, which is part of the *Book of Order*, now goes to the denomination's 171 presbyteries, a majority of which must ratify it to be adopted.

The new directory has been ten years in development. Kristin Saldine, a consultant to the writing team, likened the directory to a compass. "It is not a book of rules and regulations," she told the assembly, "but gives us bearings and direction, pointing to the primary purpose of worship—to give glory to God—and navigating between form and freedom and encouraging a variety of styles."

#### 'Regret' expressed for harm to LGBTQ/Q members


Declining a proposal to admit to and apologize for harming the lesbian, gay, bisexual, transgender, queer, and questioning community, commissioners instead opted to express deep regret for ways that those minorities of "God's beloved children" have been led to feel that they stand outside the grace of God and are unwelcome in the denomination.

At the same time, the resolution expressed the deep sorrow of all in the PC(USA) who have left the fellowship of the church, and expressed appreciation to those who have maintained relationships despite profound disagreement.

Calling for deeper conversations about theological differences, the resolution, passed by a 463-51 vote, calls upon Presbyterians to seek reconciliation and to reach out to those who have been marginalized across the spectrum of theological understanding.


# "Teaching Elder" out, "Minister of Word and Sacrament" back in


After several hours of debate, commissioners voted to send to presbyteries a proposed amendment to the *Book of Order* that would restore the previous nomenclature for ordered ministry. If approved by a majority of the

denomination's 171 presbyteries, those now called teaching elders would become ministers of Word and Sacrament; ruling elders would be elders; and commissioned ruling elders would be commissioned pastors. The vote was 320-218 to return to language in use prior to 2012, when the new Form of Government was adopted.






# Decision to reduce number of synods reversed

A decision two years ago that would have reconfigured and reduced the number of synods in the PC(USA) was rescinded by a 421-158 vote. The assembly directed synods and presbyteries to work together on a new configuration of synod boundaries that would reduce their number to between 10 and 12.

By a 380-196 vote, commissioners rejected a minority report calling for the appointment of a special committee to move the synod-reconfiguration process.




## Commitment to peacemaking reaffirmed

After a six-year churchwide discernment process, the assembly approved a lengthy report underscoring the centrality of peacemaking to Christian faith and promising to "practice boldly the things that make for peace."

"Risking Peace in a Violent World: Affirmations for Presbytery Consideration" was ordered by the 219th General Assembly (2010) to "seek clarity as to God's call to the church to embrace nonviolence as its fundamental response to the challenges of violence, terror, and war."



#### Gradye Parsons honored


A crowd of nearly 1,000 Presbyterians paused mid-assembly to pay tribute to Stated Clerk Gradye Parsons, who is retiring at the end of the assembly after thirty-seven years of ordained ministry, including the last eight as the denomination's chief ecclesiastical officer.



"Gradye could fill volumes with the thrills and spills of ministry," said longtime colleague Sharon Youngs, "but he has always stood at the helm in a gentle and secure way, his life built on relationships. God put an additional dash of pastor in Gradye's DNA. His heart runs deep and his arms open wide."

Parsons responded with characteristic humility. "It's been a privilege to do this and to have you share your stories and be able to share those stories with the rest of the church," he said. "Just don't give up on this church—DON'T!"

"Too many of us get alarined by the numbers—how many are on our side how many are on our side how many are on our side. We capitulate go along to get along. The Lord has not called us to be popular; he scalled us to be faithful. Just be faithful to what God has said to you "—Ecumenical worship preacher; Bishop Reginald, Jackson of the African Methodist Episcopal Church.



# With an apology, assembly vows to keep children safe

With tears and prayer—and a remarkable apology from Stated Clerk Gradye Parsons—the assembly unanimously approved a comprehensive policy to protect children, youth, and vulnerable adults.

Kris Schondelmeyer, a Presbyterian pastor from Toledo, Ohio, who has become the face of abuse victims in the church, had told his horrific story of being sexually assaulted by a chaperone at a national Presbyterian youth conference, and the ensuing cover up.

Immediately after the new policy was approved, Parsons stepped to the podium and said, "As Stated Clerk of the General Assembly, I want to offer to Kris a public apology for what happened to him. I know how hard it was to find justice. I offer our commitment that his child and my grandchild will be safe."



#### Commission created to deal with PC(USA) structural issues

Several recommendations that would have changed the structure and operation of the PC(USA) were rejected and commissioners instead created a vision team and a separate administrative commission to address those matters.

By a vote of 480-86, commissioners authorized the creation of a twelve-member Way Forward Commission, which would have sweeping powers "to study and identify a vision for the structure and function of the General Assembly agencies of the PC(USA)."

The assembly also created, by a vote of 547-27, a fifteen-member 2020 Vision Team to "develop a guiding statement for the denomination and make a plan for its implementation." The hope, the Assembly Committee on "The Way Forward" said, "is that the team will help us establish and reclaim our identity as the PC(USA)."



Move to divest from fossil fuel companies defeated


The PC(USA) will continue its investment in fossil-fuel companies after overwhelmingly turning back an overture Friday to begin divestment immediately. Instead, it will continue the process of selective, phased, divestment that begins with full corporate engagement.

0 of 77 Stated Meeting - August 18, 2016

Bill Somplatsky-Jarman, the denomination's associate for Mission Responsibility Through Investment, told commissioners that divestment could well reduce Presbyterians' ability to persuade energy companies to act in environmentally responsible ways—one of the purposes of MRTI. "In the real world of corporate engagement, the more stock you own the more power you have," Somplatsky-Jarman said. "You are treated much more seriously by companies that are skeptical of what you are asking for."

By a 31-25 vote, the Assembly Committee on Immigration and Environmental Issues had recommended divestment. Commissioners wound up voting for a substitute to maintain investments and corporate engagement, 460-91.




Two-state solution for Israel-Palestine reaffirmed

The assembly approved a lengthy report from its Advisory Committee on Social Witness Policy containing a re-evaluation of the denomination's historic support for a two-state solution in Israel/Palestine. The document, "Israel-Palestine: For

Human Values in the Absence of a Just Peace," says the PC(USA) "should advance those efforts that best accord with its values ... including, but not limited to, that of two sovereign states—Israel and Palestine."

Approval of the report came with a comment affirming the PC(USA)'s preference for a two-state solution and a desire to stay in conversation with partners in Israel who are working for peace.

Final text:

In response to Item 14-03, the 222nd General Assembly (2016) approves the following resolution:

Shall W-2.4011 be amended by striking the current text and inserting new text to read as follows:

"Theology of the Lord's Supper

"The opportunity to eat and drink with Christ is not a right bestowed upon the worthy, but a privilege given to the undeserving who come in faith, repentance, and love. All who come to the table are offered the bread and cup, regardless of their age or understanding. If some of those who come have not yet been baptized, an invitation to baptismal preparation and Baptism should be graciously extended.

"Worshipers prepare themselves to celebrate the Lord's Supper by putting their trust in Christ, confessing their sin, and seeking reconciliation with God and one another. Even those who doubt may come to the table in order to be assured of God's love and grace in Jesus Christ.

"In cases where baptized children who have not yet begun to participate in the Lord's Supper express a desire to receive the Sacrament, the session should provide an occasion to welcome them to the table in public worship. Their introduction to the Lord's Supper should include ongoing instruction or formation in the meaning and mystery of the Sacraments."

#### Recommendation

The Presbytery of Southeastern Illinois respectfully overtures the 222nd General Assembly (2016) to direct the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative votes:

Shall W-2.4011 be amended as follows: [Text to be deleted is shown with a strike-through; text to be added or inserted is shown as italic.]

"a. The invitation to the Lord's Supper is extended to all who have been baptized seek the presence of Jesus Christ, remembering that access to the Table is not a right conferred upon the worthy, but a privilege given to the undeserving who come in faith, repentance, and love. In preparing to receive Christ in this Sacrament, the believer is to confess sin and brokenness, to seek reconciliation with God and neighbor, and to trust in Jesus Christ for cleansing and renewal. Even one who doubts or whose trust is wavering may come to the Table'in order to be assured of God's love and grace in Christ Jesus.

#### "Baptized Children

"b. Baptized eChildren who are being nurtured and instructed in the significance of the invitation to the Table and the meaning of their response are invited to receive the Lord's Supper, recognizing that their understanding of participation will vary according to their maturity. (W-4.2002)"

#### Rationale

We acknowledge the importance of Baptism in the life of a Christian and fully support the goal that every Christian should be strongly encouraged to acknowledge the lordship of Christ in her/his life with the act of Baptism. Having said that, we also realize that the current wording in the *Book of Order* regarding who can partake in Holy Communion excludes those developing Christians who have not yet made the baptismal declaration. Children whose parents decided to not partake in infant baptism would be excluded until such time as (usually during the Confirmation experience) they themselves choose to be baptized. People who are new to the faith and are being nurtured by a congregation would also be excluded. In both of these cases it appears that the *Book of Order* would exclude these people from participation and require them to stay behind in the pews while everyone else goes forward to receive the elements.

We believe that few congregations actually follow the *Book of Order* in this regard. Holy Communion is routinely open to all who profess faith in Jesus Christ, with no mention of having to have been baptized.

We feel strongly that the *Book of Order* should be changed in the above ways so that we can walk arm-in-arm with all of our seeking brothers and sisters as we go forward to receive this holy sacrament.

# Camp Carew, What we do!





# Answers to Questions from Southeastern Illinois Presbytery The Reverend Pam Laing

Faith Journey Involvement in the church has been a norm for me for as long as I remember. Early on, at my parents' bidding, I attended Sunday School and Training Union just about every Sunday at a Southern Baptist church in Amarillo, Texas. When I was in fourth grade, because of a change in theological thought, we began attending the Presbyterian Church. Ever since, my Presbyterian roots have grown deeper and deeper and I have attended a Presbyterian Church wherever I have lived.

While in high school, my mother suffered several strokes that left her partially paralyzed. From then on I attended school half days and cared for mother the rest of the day. When I graduated, it seemed natural that nursing would be my career. My specialties turned out to be operating room and psychiatric nursing. Enjoyable as nursing was, however, it never quite felt like I was doing what was intended for me. There was always a tug to do something different. It took several years (too many!) for me to realize that the "tug" was God calling me to ordained ministry. Finally in 1994, I yielded to God and enrolled in Austin Presbyterian Theological Seminary. Since that day I've continued to grow and move forward in my faith journey.

My first call from seminary will most likely be my last called and installed position, for in July I will have been serving the same faith community for 19 years. This call has been a place for me to grow and mature in my own ministry, and one in which the congregation and I have served God well together. It is here that my education about transition ministry began, since from the start I began quiding the congregation through their time of merger. From that transition forward, we have been creative in our mission, sometimes discovering outreach and spiritual endeavors that have worked well and at other times having to realize that we could do better. Always God has walked with us. In general, my dream for a congregation in transition is that Goals for the calling congregation they are able to move through the changes they are experiencing in a way that helps them find their strengths, that reveals to them the presence of God in their midst, and prepares them for the next adventure God has in store for them. Usually such a process requires a willingness to review what has been, not in order to stay there, but so they can be reminded of those things that make them unique. With that awareness, my hope and prayer would be that the congregation, especially the leadership, would be ready for the surprises and opportunities God will provide and can build a vision of what God is calling them to be.

As I think specifically of First Church, Effingham, I know that they have lost a long term pastor due to illness. There will be grief work to be done, I'm sure. In addition to all of the above goals, my prayers for them is that they engage in a healthy grief process so that they are able to cherish the memories of their beloved pastor, but also can move forward into the future for which he has helped them prepare.

My Goals My goal is for me to work through the grief of leaving one long-term pastorate while also looking toward the future with great expectation and excitement. I have a new understanding of transition because I am living through one. My plan is to continue the spiritual practices of daily Bible reading/reflection and of seeking God's leading for each new day, which are fundamental to the work that we would be called to do. Since I will be in a new pastoral situation, reassessment and matching of my gifts to the particular congregation I serve seems in order so that I am able to better discern where God is leading me and them. I look forward to enjoying the opportunities for growth and new learning that are before me.

In regard to my personal health and growth, my goal is to continue following the recommendations of my physicians and to take time for myself in order that my energy and passion can remain high.

Presbytery and in the denomination is a priority in my service to the church. This holds true for me individually and will hold true in my leadership and encouragement with and for the people with whom I serve.

I have been a Presbyterian since the 4th grade, and as such volunteered in **Presbyterian Polity** many capacities over the years before being ordained as a Teaching Elder. That includes service in Presbyterian Women on the local, Presbytery and Synod level, with my last position being Moderator of Synod PW in the Synod of the Sun. PW historically has some of the best leadership training available, so the Book of Order has long been a tool for me. In addition, I served on session of my congregation and was schooled in applying the guidelines and directives of the book to particular situations. Then and since becoming a teaching elder, I have learned the importance of knowing the "rules" but also of being aware that situations call for a willingness to adapt to where God is leading us. There always needs to be a readiness for the reforming and renewing Spirit of God to be at work. Working with sessions and committees and watching them discern and decide what they are called to do is for me one of the greatest signs of God at work in the world. The new Book of Order offers flexibility for a pastor and session to respond together to the emerging needs of the congregation. The confessional statements of the PC(USA) give us our identity and provide a Confessions framework from which individual church members and leaders, congregations and higher ruling bodies can draw from as they serve Christ in each one's specific context and situations. The Confessions are a good source for Presbyterians as they carry out the belief that we are reformed and always being reformed by God. I particularly find meaning in the Declaration of Faith, as it provides several examples of God's transforming and reforming power.

The Lord's Supper & Baptism The sacraments are signs by which we as followers of Jesus Christ can connect with God and one another. Through the ordinary elements of water and bread we show outwardly that inwardly we belong to God in Christ and covenant with God and other believers to be the church in the world. Baptism: In Baptism we are adopted into the body of Christ and marked as God's own forever. Baptism is about grace and inclusion, about dying to that which separates us from God and being cleansed and renewed for the purpose of serving as a part of Christ's body in and for the people of the world. The Lord's Supper: Through the shared meal of the Lord's Supper, we in the church celebrate and give thanks that we belong to God; we remember all that God has and is doing for us – especially the salvation that is ours – and through Christ's spiritual presence with us we are united and led forth to do God's will.

#### COVENANT BEHAVIOR FOR "COMMITTED CONVERSATION"/DIALOGUE

(Listening and Speaking in Prayer)

#### **GUIDELINES**;

#### When Speaking:

# 1. Speak only for yourself (your personal experience and expectations): "My experience is..." "I feel..." not, "You made me feel..." "I want..." "I need..." etc.).

#### 2. Stick to the "issue";

State your position/belief/hopes and your reasons, without assigning "motive" to those with whom you disagree. Say, in particular what you do believe or want, rather than what you do not believe or want

#### 3. Before you start to speak:

Be as clear as possible about what you want to say and how you want to say it.

4. Be Concise. Expect to complete what you have to say within 2 minutes or less each time you speak: Help each other be accountable for honoring this time commitment so that there is equal opportunity for all to speak. Do not expect to speak again until all who want to be heard have spoken once.

#### When Listening:

1. <u>Listen carefully</u> (with care for the one speaking):

Seek only to be clear about what is being said. Set aside the temptation to imagine a response at the same time you are trying to listen, so that you can give your full attention to hearing what the other is trying to communicate.

#### 2. Ask questions for clarity only:

Check your understanding by "reflecting" (saying back to the speaker) what you understood the speaker to say. Ask or "check" only after the speaker is finished speaking. Allow 1 minute for seeking clarity before moving on to the next speaker.


#### Regarding the whole Conversation:


