#### Presbytery Announces its 5-year Financial Projection Plan



On behalf of the Financial Management Task Force, (*TE Bill McLean, Presbyter for Congregational Care, TE Cindy Bean, Stated Clerk, RE Paul Saegesser, Presbytery Treasurer, TE Dennis Hamilton, Tilden; TE Stacy Tate, UCC; and RE Bill Capel, Champaign, McKinley)* Stated Clerk Cindy Bean presented a timeline of the Presbytery's membership and leadership changes since 1972 focusing on the last 10 years. **In 1972**, the Presbytery had over 27,000 members and 123 congregations. **At the end of 2015**, the presbytery had 6,787 members, and today there are 83 congregations. **In 2006** there were 110 minister members of Presbytery and 33% of them (37) were Honorably Retired or Members at Large. **In 2016** there are 94 minister members and 51% (48) of whom are Honorably Retired or members at large. While there are fewer congregations and active members, the Presbytery has a

smaller percentage of minister members working with the congregations. This is a big change that requires more service from each minister member. Meanwhile, the Presbytery staffing has stayed the same during those same 10 years with the exceptions of the Presbyter for Congregational Care being reduced from full-time to 65% time and the Camp Director position being increased from a 1/3 time position to a full time position.


In 2013, the Presbytery formed a Generosity Task Force to address the stewardship issues of the presbytery. After attending a Stewardship Kaleidoscope conference the group narrowed their focus to addressing congregational stewardship education and shared what they had learned with many of the congregations in this presbytery. This left a void since there still wasn't a group to address the Presbytery's financial issues. In 2014, General Council formed a Financial Management Task Force (FMTF) and they developed a new Presbytery financial policy and long range financial projections for the Presbytery. The FMTF also worked with the Camp Carew Finance Committee to develop better reports, work toward a financial review and understand common struggles.

Throughout the life of the Presbytery, there has been a strong commitment to support the ministry of Camp Carew. **In 2010**, the Presbytery committed to funding a full-time Camp Director salary (for five years and this was renewed for two additional years) in addition to providing some Camp Carew Program support. These expenses were to be paid from the Presbytery's Mission Giving received from the congregations. Cindy shared that the decline in mission giving over the years has forced the Presbytery to take from its per capita funds and reserves to meet the financial commitment for the full-time Camp Director and forced a reduction in Program Support.

The Presbytery has also made a commitment to hold per capita steady despite GA per capita increases every year. The Presbytery's portion of the 2017 per capita will be \$28.70, a decrease of 22 cents from 2016. In the last few years, the Presbytery has lost over 1,000 members due to churches closing or being dismissed to another denomination. Cindy gave examples of how the financial support of the Presbytery could increase – increased membership in the congregations, increased Mission Giving, increase reserves/investments through donations, draw more out of reserves/investments that are not permanently restricted.

Cindy presented a five year financial projection plan for the Presbytery. If nothing changes financially, the Presbytery will deplete its reserves by 2019. The Presbytery must begin addressing the shifts in our presbytery which have led to declining resources (decreasing number of congregations and minister members to serve congregations, decreasing per capita and financial reserves). The bottom line – the Presbytery does <u>not</u> have the option to "close up shop" and cease to be a presbytery. The options are to:

- Increase income
- Decrease expenses
- Share expenses for some functions with another presbytery
- Dissolve as a presbytery and join with another presbytery, thereby increasing our already large geographic borders
- Pursue other creative options, like dividing into smaller presbyteries that can be staffed by one part-time person.

This year there were 2,578 wells installed. It was announced that the cholera virus has been eradicated in the areas where the wells have been installed.
