As General Assembly Co-Moderator, Jan plans to serve as examples of shared ministry in the denomination, in the hopes that what they model will be manageable and sustainable to a greater number of Ruling Elders and Teaching Elders.

FINANCIAL MINISTRY TASK FORCE (FMTF)

Stacy Tate (TE), Friedens UCC, presented the following FMTF report at the August 24th Stated Meeting

I want to briefly update you all about the progress being made by the newly renamed Financial Ministry Task Force. As you may know, the General Council created the FMTF a couple of years ago out of the recognition that our expenses were outpacing our income at a rate that threatened the Presbytery's financial viability – putting it another way, the revenues we have been receiving has not been enough to meet our expenses.

As you may know, religion is a people intensive task. Our goal has been to avoid sudden, radical, drastic cuts and to move in a deliberate, planned, and humane manner to adjust our expenses without increasing the per capita.

One action that members of the Presbytery have approved is that later this year the presbytery office will be transitioning from the current "physical" office location located in downtown Decatur to an online "virtual" office using a model built on the successful experiment in working "virtually" that the Stated Clerk, Presbyter for Congregational Care, and Treasurer having been transitioning into for several years. In the new virtual office, Brenda and Marsha will remain reachable by both phone and email as they continues to serve the presbytery in the same outstanding way they have for years. Then when Brenda retires next summer, the presbytery will dissolve the administrative assistant position and reallocate those tasks.

These efforts are designed to impact the presbytery's expenses while minimizing the impact on the services provided to congregations. If you have questions or concerns about this transition please talk to members of the General Council for more information.

Other changes are in the works as the Financial Ministry Task Force, Presbytery Council, and we in the Presbytery continue trying to discern the best ways to serve our 80+ constituent congregations.

SYNOD OF LINCOLN TRAILS

New Pastor Support Program

The New Pastor Support Program is open to any pastors in this synod newly ordained to service within the Presbyterian Church (U.S.A.). Regardless of the setting for the call: be it congregational, chaplaincy, community service or teaching, persons in their first three years of ordained service are invited to participate in the three year program which includes six three-day retreats and other one-day small group regional gatherings.

Our purpose is to support newly ordained pastors as they grow in leadership capacity, to build community and friendships and enjoy daily worship, prayer, and renewal. The three or four leaders of each three-year cohort are experienced pastors and church leaders from among the eight presbyteries in Illinois and Indiana, including a member of the synod staff. Retreats are held at Presbyterian camps or conference centers in this synod. Content offered at each retreat is developed in response to the particular needs and experiences of that cohort. New groups are started at least biennially.

MARION MEDICAL MISSION (MMM) Celebrates its 27th Year of Installing Wells

Marion Medical Mission (MMM) is now in its 27th year of installing wells. It is the largest church related employer in the southern part of PSEI. Since 1990, Marion Medical Mission has built over 30,000 wells, covering an area of roughly 57,000 square miles in Malawi, Zambia, and Tanzania. These wells provide an estimated 4 million to the extreme rural poor (2.4 million children) with a sustainable source of safe drinking water.

In 2016, American volunteers and African villagers built 2,732 wells in remote rural villages in Malawi, Tanzania and Zambia in a 14-week period beginning September 1, providing an estimated 409,800 people (including 245,880 children) with a source of safe drinking water that they can afford to maintain.

MMM's 2017 goal is to build 2,800 wells. Last month, 37 U.S. volunteers (including two from the Presbytery of Southeastern Illinois, in addition to Tom and Jocelyn Logan) will travel to Africa for this year's well season.

MMM builds a well for \$400, far below what it costs other organizations to build the same well. Villagers make the brick, gather the clay, stone and sand, and provide the unskilled labor. MMM provides only what the villagers cannot – the cement, pipe, pump, and skilled African labor. 100% of all designated donations go to their designated purposes. 100% of all undesignated donations go to the mission field in Africa.

Churches in the Presbytery of Southeastern Illinois have been faithful supporters of Marion Medical Mission, and they continue to need your support as they begin a new season of well building. Pray for the volunteers, the African staff, and the villages – and when you pray, move your feet. Help tell this extraordinary story. Contribute money to fund wells. You are needed, you are important, and you make a difference.

First Presbyterian of Murphysboro Community Garden and Labyrinth Update

When I began serving First Presbyterian of Murphysboro in 2016, I discovered that their Outreach Committee wanted to start a community garden and put in a labyrinth as part of a holistic health program. At that point, some general plans had been made for both but nothing concrete had been done.

Then the committee decided to apply for a Mission and Ministry Grant from the Presbytery. We worked on the application and sent it in for consideration in May of last year. In short order, we were awarded a nice grant of \$2500. After that, work on the two projects took off in earnest.

We first began on the labyrinth. That work has gone a little slower than work on the garden because we have spent a lot of time figuring out what we want to do. We invited a local labyrinth designer to meet with us and he made some good suggestions. We spent some time reading about various labyrinth designs. Recently, the committee met and walked the labyrinth at St. Joseph's Hospital in Murphysboro.

This is what we have accomplished so far: we used yellow tape to make an outline of the labyrinth on a nice grassy area behind the church. In the center of the area that will be the labyrinth is a small tree. A bench has been installed around the tree.

We want to put in a brick labyrinth. We have gathered the bricks but are trying to decide whether to dig a small trench along the outline of the proposed labyrinth and lay them flush with the surface of the ground or raise the bricks a little above the surface. We are killing the grass inside the labyrinth by covering it with sheets of dark plastic.

Regarding the community garden, we began publicizing our intent to create such a garden in February 2017, using the usual methods (social media, flyers, newspaper announcements, word of mouth, and so forth). We also began working with the Jackson County Extension Service and some experienced gardeners in the area. At our first meeting, a horticulturist from the Extension Service gave a presentation. Afterwards, we signed up those present who were interested in participating in a community garden and began to make our plans. The group meet frequently over the next few weeks and assigned garden plots and made assignments.

Fast forward to July, 2017. A small but dedicated group of church volunteers and community members is now tending a thriving garden. They don't meet often but talk on the phone and sometimes meet at the garden while working. It is a very "organic" process, as is the garden itself! They informally decide who is going to water, to attempt insect eradication, and other tasks. The garden looks great now. There is a veritable bumper crop of tomatoes, plus a few squash, peppers, and climbing beans. Some produce has already been given to the Murphysboro Food Pantry.

Thank you, Mission and Ministry Team, for the very helpful financial grant. And thank you, Presbytery of Southern Illinois, for having the vision to make these funds available. All the glory goes to God.
