# PLEASE BRING THIS DOCKET AND OTHER PAPERS WITH YOU TO THE PRESBYTERY MEETING!

Motions and resolutions from the floor MUST be presented in writing.

**INTRODUCTION OF NEW BUSINESS** – This is an item on the docket placed there to provide an opportunity for any member or commissioner to introduce matters that might not be a part of a Committee's report. This is your method of docketing a matter that you feel is important to the business of the Presbytery. Under the procedure, this new business will be referred to the Committee having cognizance over this matter. If at all possible, prior to the start of the meeting please give the Stated Clerk a summary of your item for new business so he/she can advise the Moderator.

**REMINDER TO CHURCHES** – If your elected commissioner or alternate is unable to attend a presbytery meeting, the Session may appoint another elder, either currently serving on the session or not, to serve as commissioner for that meeting. ALL visitors attending from your church need to either pre-register or sign in at the registration table at the meeting.

**HOW TO PRE-REGISTER** – Go to <u>www.psei.net</u>. Under the banner near the top of the page you will see *ministries* listed – put your cursor on that tab. On the drop-down menu, click on *Presbytery Meetings*. Here you will find the entire list of meeting documents. Read and print the ones you may want for the meeting.

# Committee on Ministry

#### Waiver of Rotation - McLeansboro

**It is RECOMMENDED** that the Presbytery grant a Waiver of Rotation (G-2.0404) for McLeansboro session for the following elders for a three-year term: Francis Benbrook, John Warner, Heidi Hart, Carla Browning, Debbie Phillips, Heath Laswell. Will need to be renewed in 2020.

Rationale: Church membership is now 18 (It was 29 in 2014) and all of the available families in the church are represented on Session.

#### Waiver of Rotation – New Haven

**It is RECOMMENDED** that the Presbytery grant a Waiver of Rotation (G-2.0404) for the New Haven session for the following elders for a three-year term: Faye Wilson, Zella Medlin, Wayne Wilson, Betty Jo Roark, Janice Ambrous, James Ambrous. Will need to be re-evaluated in 2020.

Rationale: The New Haven Presbyterian Church has 13 members. Some of these are not available for Session Service. As a result, the Session does not have any turnover. Recently two members of the former Ridgeway church joined the New Haven Church, and they were immediately elected to Session (Danial T. Lassner and Elaine Lassner). However, the other members of the New Haven Session need to be granted permission to continue their duties on Session.

#### **Carlson – Champaign, First - Dissolution**

**It is RECOMMENDED** that the Presbytery, at the request of the Rev. Chuck Carlson and the Champaign, First, dissolve the pastoral relationship between Mr. Carlson and the Champaign, First Church as of November 20, 2017.

#### APPLICATION PROCESS

- Mission Initiative Grants are one-time grants of 'seed' money to help begin new congregation based missional activities.
- Missional activities, in this sense means hands on mission in your community that is more participant driven than financially driven.
- These grants are for NEW mission endeavors in your community.
- These one-time grants are for amounts up to \$1,500. Grants may be awarded at amounts lower than requested based on both number of grant requests and level of missional participation.
- Grant recipients will be asked to share progress stories 6 months and 1 year after receipt of the grant.

Please note that all applications include signatures of either the **Pastor** or **Clerk of Session** of the congregation and an appropriate representative of the Presbytery indicating their awareness of and/or endorsement of the application.

All applications will be reviewed by the Standing Committee on Leadership Development at each Synod meeting with deadlines 2 weeks prior to each meeting. Deadline for October 21-22 Synod meeting is October 3<sup>rd</sup>.

#### Synod of Lincoln Trails Mission Initiative Grant First Presbyterian Church, Mount Vernon, Illinois

1. <u>How the project started</u>. Small groups of homeless people have been living in the cemetery behind our church for years. Last winter, a member of our congregation suggested that we hang a clothes line and put usable items of warm clothing on the line, along with a note inviting people to take what they needed. It seems to be very popular with the folks living in the cemetery, and we now refresh the clothing selection frequently.

Our congregation, however, wanted to do more to extend God's love to this group of homeless people, as well as to the people living in the lower-class neighborhood adjacent to our church property. For this reason, last month we piloted a program offering a free lunch to anyone in the community who would like to join us, with a special effort to include the homeless and the financially-struggling people in our community. As a trial for this effort, we have hosted two lunches. Both have had about 50 people in attendance, and indeed, we have reached the impoverished population we hoped to reach, as well as the community in general. We would like to continue this effort, and to spread God's love.

2. <u>How grant funds will be used</u>. We endeavor to offer free monthly meals to people in our community, with a special effort directed toward people who are food insecure. Our plan is to offer a pleasant meal rather than be a soup-kitchen. In our two trial meals, we have used our church china rather than paper plates, and have made an effort to provide a warm and welcoming setting, rather than simply providing sustenance.

We are requesting a \$1,500 grant to launch our monthly meal program in earnest. Each month we would use about \$20 for publicizing the event, and \$80 for food costs. Church members would provide the labor. Additionally, we will hold a yearly fund raiser at our church to secure money to continue this effort past the life of the seed-money provided by the Synod.

3. <u>How the project will be aerated, irrigated, and fertilized</u>. In keeping with your engaging tree analogy, here is how we would aerate, irrigate, and fertilize this project.

Aeration, preparing the soil, has already begun through our contact with the homeless in our community. Through our clothesline project, we are acquainting the homeless population with the good-will of our congregation. In addition, one member of our congregation has accompanied a local homeless advocate on nighttime visitation rounds to talk to homeless people where they are sleeping, an effort which will continue periodically in the future. This effort allows a face-to-face invitation to join us for a meal, as well as to remind the homeless of God's love despite their challenging circumstances. Additionally, several members of our congregation to join us in food and fellowship.

Irrigation, transporting nutrients and water, would be accomplished through consistency and trust building with the target population. Since our present congregation tends to be largely middle-class, building a trusting relationship that is based on mutual respect rather than charity with the financially-struggling individuals in our community will take time. We think it is important not to "hide" in the kitchen and simply offer food, but to sit down and eat at tables with our guests in a pleasant and convivial atmosphere.

Fertilization, the continued provision of nutrients, would be provided through the congregation's continued involvement in this project. In our pilot meals, our Mission Team has provided all the food and labor. Other members of the congregation have expressed an interest in assisting, and will be a very welcome addition to this effort in the future. Additionally, our church has a tradition of fund raising through "mission meals," where we share an after-church pot-luck meal and members of the congregation generally donate whatever money they might have spent at a restaurant toward a particular mission project. At least one pot-luck fund-raiser a year will be dedicated to raising money for the monthly community meals so this project can continue well into the future. #### **RECOMMENDATION C**

#### **PSEI Treasurer Resignation**

**It was VOTED to RECOMMEND** that the Presbytery receive the resignation of Treasurer Ruling Elder Paul Saegesser effective December 31, 2017, with thanks for his many years of service. He will complete all year end financials, tax forms, tie up the current fiscal year on ACS and provide W2s and information for the 2017 review. Will need to recognize him – at the next Presbytery meeting if he is present.

### **RECOMMENDATION D**

#### PSEI Treasurer Election

It was VOTED to RECOMMEND that the Presbytery elect and approve the terms of call of Rev. Wade Meranda to PSEI Treasurer effective January 1, 2018 for a one year term with the following terms: \$1000/month based on an average of 8 hours/week at \$30/hr.

Rationale: He will begin work to set up Church Windows, a new chart of accounts (for more transparent and viewer friendly reports), etc. prior to January 1 to transition from our current financial and database system (ACS) which will save us \$4200/year. In addition, all financials will be handled with new controls to take burden off current staff.

He requested a one year agreement and this would help us transition into future options. He would have to resign his position as President of the Trustees and on General Council. Wade stepped down from a Not-for Profit position that was taking up a block of time in order to be able to take on this additional responsibility.

The Vice Moderator position on General Council would not be filled, however if the Moderator was not able to attend a General Council meeting the PSEI Moderator will serve as the General Council Moderator pro-tem. Additionally, the Vice Moderator of PSEI would serve as the General Council Moderator pro-tem should the PSEI Moderator be unable to serve. This would be evaluated in October 2018 by COR and General Council. This requires 2/3 approval in order to pass.

Current language in Standing Rules: At the last Stated meeting of the year, the Committee on Representation shall submit candidates for Moderator and Vice Moderator of Presbytery; **Moderator**, **Vice-Moderator**, and members of the General Council; and Moderators and members of committees, with the exception of the Committee on Nominations. Nominations shall also be accepted from the floor.

### The Presbytery of Southeastern Illinois Bills and Overtures Subcommittee Report November 16, 2017

First Presbyterian Church Monticello, IL

### **RECOMMENDATION A**

**It is RECOMMENDED** that the Presbytery submit the following overture to the 223<sup>rd</sup> General Assembly for approval. This overture was drafted and approved by the session of the First Presbyterian Church, Marion, IL Proposal:

To amend

G-3.0201 Composition and Responsibilities

As follows:

The session is the council for the congregation. It shall be composed of those persons elected by the congregation to active service as elders, together with all installed pastors and associate pastors. All members of the session are entitled to vote. The pastor shall be the moderator of the session, and the session shall not meet without the pastor or designated moderator. *In the case of the sickness or absence of the pastor or designated moderator, the pastor or designated moderator may appoint a member of the session to preside, or the session, after having obtained the approval of the pastor or designated moderator, may convene and elect another of its own members to preside. Such an appointment should not be routine and shall only be for a single meeting.* If there is no installed pastor, <del>or if the installed pastor is unable to invite</del> <del>another moderator,</del> the presbytery shall make provisions for a moderator. Presbyteries shall provide by rule for moderators when the session is without a moderator for reasons of vacancy or inconvenience.

### Rationale:

In many presbyteries, we have a shortage of ministers. We also have many churches that are not served by a minister. We have numerous ministers who give of their time to moderate sessions that they do not serve as pastor. Many congregations and pastors are having conversations about part time pastoral leadership, bi-vocational pastors, and temporary pastoral leadership. This results in the need for both moderators and flexibility.

While recent changes to Robert's rules and the Book of Order allow the use of technology to allow for meetings to occur when members are physically separated, for many churches these are not viable options. We have hearing issues that make phone conferencing difficult. We have issues with technology and its accessibility in many of our congregations. While these options are good, and a step in the right direction, they aren't practical or even functional for all congregations.

While good planning may reduce the need for this measure, there are emergencies and special circumstances. It is not always possible to reschedule a meeting, and some business that comes before the Session comes on very short notice with a short turnaround needed. In those cases, this measure would allow for the work of the church to continue.

This measure is not intended to allow elders to be appointed to moderate the session of the congregation of which they are a member on a routine basis or for an indefinite period of time.

### **RECOMMENDATION B**

**It is RECOMMENDED** that the Presbytery concur with the following overture submitted by Presbytery of Mission to the to the 223<sup>rd</sup> General Assembly for approval. This recommendation for concurrence was approved by the session of the First Presbyterian, Danville, IL

### Ovt 007

On Establishing a Grant to Develop Resources to Educate Entities Regarding Serious Mental Illness Issues—From the Presbytery of Mission.

On June 24, 2017, the Presbytery of Mission overtures the 223<sup>rd</sup> General Assembly (2018) to:

A. Recognize the 10<sup>th</sup> anniversary of the "Comfort My People: A Policy Statement on Serious Mental Illness"<sup>1</sup> approved at the 218<sup>th</sup> General Assembly (2008) of the Presbyterian Church (U.S.A.) and to acknowledge the relevancy it still holds for our Church and society in 2018.

B. Establish a \$250,000 grant to be used to implement the provisions of this Overture. The funds will be used to develop plans of action and resources that will be used by presbyteries, congregations and seminaries of the PC(USA) to further educate these entities within PC(USA) regarding serious mental illness issues with the intent to provide a foundation for action within the denomination.

C. While it is acknowledged that all of the recommendations within the "Comfort My People"<sup>2</sup> statement are worthy of implementation, this Overture focuses on those action items that are foundational to any development of long term policies and plans for action within PC(USA). Grants to be awarded will therefore focus on the following recommendations:

- i. Presbyteries: 6 (a-d, g), 10
- ii. Congregations: 9 (a, d-k, o, q, t)
- iii. Seminaries: 14 (a-e)

**D.** Conduct a review and evaluation of the actions that have been taken since the Policy Statement was adopted with a report to be presented at the 224<sup>th</sup> General Assembly.

a. Survey of presbyteries, congregations and seminaries to evaluate how these organizations have responded to the Policy Statements recommendations.

b. Based on survey results, recommend specific activities designed to focus and implement measures to enhance mental health initiative in presbyteries, congregations and seminaries.

E. Review, update and present a second edition of "Comfort My People" for approval at the 224<sup>th</sup> General Assembly. This review and update would examine terminology, facts, findings, hyperlinks, and add any additional resources (i.e. websites, books, movies) published since 2008 that would add value to the statement.

#### Rationale

The "Comfort My People: A Policy Statement on Serious Mental Illness" approved at the 218<sup>th</sup> General Assembly (2008) of the Presbyterian Church (U.S.A.) was a profound statement of faith for persons, families and communities living with mental illness. This statement has aided in the message of hope through educating Christians and reducing the stigma associated with mental illness.

In recognition of its tenth anniversary, it is our desire to see this statement reimagined and instituted as a priority within our denomination and put into practice in our presbyteries, congregation and seminaries. Our hope is to see this document serve as an instrument for God's love in the lives of those who still feel as if they are living in the "The Land of Exile" within their own communities.

Accepting that our denomination has allocated limited resources to ensure these recommendations are effectively implemented, we believe that by allocating funds that will be available to these entities as grants, there would be a grassroots effort that would ensure "God's Call to Comfort" is honored.

Finally, we strongly believe God is still calling the Presbyterian Church (U.S.A) to be a prophetic voice within our contexts to comfort God's people. This overture will demonstrate our denomination's commitment to serve those who live with mental illness and their families/communities in the process of healing and wholeness.

### **RECOMMENDATION C**

**It is RECOMMENDED** that the Presbytery concur with the following overture submitted by Presbytery of Santa Fe to the to the 223<sup>rd</sup> General Assembly for approval.

### **Ovt 003**

On Amending G-3.0307 to Clarify the Responsibility of the Presbytery—From the Presbytery of Santa Fe.

The Presbytery of Santa Fe respectfully overtures the 223<sup>rd</sup> General Assembly of the PCUSA as follows:

Amend G-3.0307 as follows: [Text to be deleted is shown with a strike-through; text to be added or inserted is shown as bold and/or italic.]

G-3.0307 Pastor, Counselor, and Advisor to its Pastors Ministers of Word and Sacrament and Congregations

Presbyteries shall be open at all times to communication regarding the life and ministry of their congregations.

Each presbytery shall develop and maintain mechanisms and processes to serve as pastor and counselor to its <del>pastors, both</del> *ministers of Word and Sacrament,* <del>ruling elders commissioned to pastoral service</del> *commissioned pastors*, (also called commissioned pastors (also known as commissioned ruling elders), as well as the *and* certified Christian educators of the presbytery; to facilitate the relations between the presbytery and its congregations, <del>pastors,</del> *ministers of Word and Sacrament, commissioned pastors*, and certified Christian educators; and to settle difficulties on behalf of the presbytery where possible and expedient.

#### Rationale

The Presbytery of Santa Fe was one of the concurring presbyteries on the 2016 overture that became Amendment 16-C, recommendations C.1 through C.8, ratified by a majority of the presbyteries. We are mindful of the valid criticism of recommendation 16-C.6 (G-3.0307) raised by the Advisory Committee on the Constitution, as well as other concerns about repetitive wording. We believe this can be easily remedied by our proposed amendment.

### **RECOMMENDATION D**

**It is RECOMMENDED** that the Presbytery concur with the following overture submitted by Presbytery of Hudson River to the to the 223<sup>rd</sup> General Assembly for approval.

### **Ovt 006**

On Directing the Board of Pensions and the Foundation to Divest from Fossil Fuel and Actively Invest in Securities that Focus in Renewable Energy—From the Presbytery of Hudson River.

#### The Presbytery of Hudson River overtures the 223rd General Assembly to

1. Commend the Board of Pensions and Presbyterian Foundation for creating fossil free options for participants, and the Mission Responsibility Through Investment Committee for increased engagement with companies in the Fossil Fuel industry-- actions that embody the beginning of a faithful response to the devastating and urgent reality of climate change.

2. Recognize that by continuing to hold investments in the fossil-fuel companies that most egregiously contribute to the climate crisis, the PC(USA) is complicit in harming God's creation and "the least of these" who are disproportionately affected by climate change.

**3.** Direct the Board of Pensions and the Presbyterian Foundation to divest from the fossil fuel industry.

4. Direct the Board of Pensions and the Presbyterian Foundation to actively seek out and invest in securities of companies whose predominant focus is in renewable and/or energy efficiency.

5. Direct the Board of Pensions and the Presbyterian Foundation to report to the 224<sup>th</sup> General Assembly (2020) about their progress in effecting recommendations 3 and 4.

#### Rationale

People on the front lines of climate change, particularly people of color, are disproportionately impacted by climate change. Countless individuals and organizations among "the least of these" have prophetically called upon the world to divest from fossil fuels. Earlier this year, for example, Ladonna Brave Bull Allard, one of the Native Water Protectors at Standing Rock said, 'We will be everywhere to let people know that there's a better way to live, there's a better way to live with the Earth, with green energy, and that it's time for us now to start divesting from fossil fuel, because we must save the water. We must save the water." We are thus called to take prophetic action in light of these voices and the imminent dangers on which they shed light.

The PC(USA) has debated divestment from the fossil fuel industry during the last two General Assemblies (221st in 2014 and 222nd in 2016).

In 2014, the Presbytery of Boston sent the overture "On Divestment from Fossil Fuel Companies" with 11 presbyteries concurring.

In 2016, the Presbytery of San Francisco sent the overture "On PC(USA) Fossil Fuel

Divestment" with 31 presbyteries concurring.

Prior to the 222<sup>nd</sup> Assembly, nine former moderators signed a letter urging the commissioners to support the overture to divest.<sup>3</sup> Their reasoning included, "because of the grave and urgent threat of climate change and the fossil fuel sector's well-documented and unyielding refusal to change, it is no longer morally or ethically right for the PC(USA) to profit from companies that are creating ecological destruction and human suffering on such a monumental scale."

Our denomination has already recognized the moral mandate for humanity to shift to a sustainable energy plan in a way that is both just and compassionate, not least of which includes the support of carbon neutrality in 2006. These statements have all been founded on the biblical call to love and care for creation.

We have actively worked as a denomination to reduce our use of fossil fuels and shrink our carbon footprint in our congregations and individual lives. These biblical and denominational mandates compel us to look at our collective investments.

As a denomination, we have long held that we cannot profit from the companies whose policies are harmful to any living thing. For nearly a century, the church has not invested in companies producing alcohol, tobacco, gambling, the military, or those that contribute to violations of human rights. The General Assembly thus declared in 1968, "the [Church's] power to spend and to invest includes the power to refrain from spending or investing. The church has not only the right but the responsibility to be selective in the use of its funds."

The General Assembly reinforced this form of stewardship in 1992, affirming that it does not and will not invest in any "sin stocks." In addition to these broad industries, General Assemblies have also divested from the Duke Energy coal mining company because of its treatment of its workers, Chevron after it sold fuel to the South African apartheid government, Talisman Energy for building a pipeline in Sudan that threatened human rights, and Hewlett Packard, Caterpillar, and Motorola for profiting from human rights abuses in the occupied Palestinian territory.

Some of these divestment actions came after a long process of corporate engagement by the church's Mission Responsibility Through Investment (MRTI) committee. Other divestment decisions were made outside the realm of MRTI.

Climate change represents deep harm to the whole biosphere, including especially marginalized people, so it is imperative that we would divest from the industry most responsible for that harm, as outlined in the Carbon Underground 200<sup>4</sup> list

And already as a denomination we are taking some steps. The Foundation has introduced financial products that provide comparable return on investment without supporting fossil fuel companies, and the Board of Pensions has a fossil-free option for their 403-B plan. Synods, presbyteries, congregations and individuals have moved their investments to such funds, and we commend them for doing so.

But while these actions among individuals and various Presbyterian entities are faithful responses to the growing crisis of climate change, they fall far short of the institutional actions necessary to make a significant difference. It is time for fossil free investments to be the norm instead of the option.

#### **DePew - Transfer**

**It is RECOMMENDED** that the Presbytery receive into membership the following: *Honorably Retired* Dwain DePew and request his transfer from Santa Fe Presbytery.

### **Barrett – Membership Status**

**It is RECOMMENDED** that the Presbytery strongly recommend that Wayne Paul Barrett move his membership to the Presbytery of residency and that his member at large status be approved through December 31, 2017 in order to facilitate his transfer. If it is not completed by January 1, 2018, he will be enrolled as an Inactive Member of PSEI.

### Mt. Vernon

COM recommended that the Mt. Vernon session recommend to the congregation that they set the terms of call for the pastoral position to <sup>3</sup>/<sub>4</sub> time beginning January 1, 2018. This was approved at a subsequent congregational meeting. **It is RECOMMENDED** that the Presbytery appoint an Administrative Commission to begin working alongside the Mt. Vernon session in 2018 as they address their financial, stewardship and physical plant challenges while also looking at pastoral leadership and staffing options. Beginning January 1, 2019, the Administrative Commission will begin an evaluation in concert with the session Moderator, the session, and the congregation to ascertain the effectiveness of the <sup>3</sup>/<sub>4</sub> time position and any other changes undertaken. This evaluation will be shared with the Committee on Ministry no later than July 1, 2019.

The Commission will consist of 5 to 7 members including a member of the Commission of Trustees, a Committee of Ministry member and 3 to 5 at-large members. **It is RECOMMENDED** that the Presbytery allow the General Council to appoint members to serve on the Administrative Commission and report those appointed at the next Stated Meeting of the Presbytery.

### Incoming Questions for Candidates for Calls in the Presbytery of Southeastern Illinois- Dwain DePew

1. Tell us about your faith journey and what has led you into the parish ministry.

I was raised a Sunday morning orphan as my parent took us to the 1<sup>st</sup> Baptist Church on Sunday mornings and left us there. As my faith developed I came to understand that Jesus, the Christ, as indeed my savior and lord. At the age of 12 I "walked the aisle" and was baptized.

My interest was in astrophysics as a teenager, but I also suffered from a great deal of emotional pain, culminating in a minor breakdown and aborted attempts at suicide. During this time a youth group formed at the church and my best friend encouraged me to join him in attending. There a devotion about the lady brought to Jesus for adultery hit me as a path to hope. About a year later I felt the call to ministry.

I arrived at SIU-C and was immediately invited to attend church on Sunday mornings at the Marion Federal Penitentiary. I also joined the Walnut Street Baptist Church and participated in their college/high school group and worked in their Saturday night coffee house. In the coffee house I was involved with the Jesus People working the streets of Carbondale. In addition my understanding and experience of the Holy Spirit was expanded.

In college my understanding of the world from the sciences and the Baptist fundamentalist view of the world came into conflict. I was invited by the powers that existed at that time to leave the denomination.

I began attending the Presbyterian Church in Carbondale, found the theology and worship to fit my own understandings of God and the way to positively worship God. My desire to enter the parish ministry increased during this time. We ended up in Morton, IL were the pastor, Richard Brownlee encouraged my interest and lined me up with the CPM.

I then attended Union Theological Seminary in Richmond, VA (Union Presbyterian Seminary), graduating in 1980. All of my work there only encouraged me further to explore the parish ministry.

2. Share with us your goals and dreams:

- for the congregation to which you are being called

Since I am retired, at present I simply want to be engaged in a congregation that seeks to develop and exercise our spiritual being as well as engaging in helping our society live into the Kingdom of God which is filled with justice, peace, and hope.

- for your own professional growth, including plans for continuing education

Again, as a retired clergy I do not at present have any long term plans for professional growth unless it is specifically oriented toward the needs of a congregation. I do continue with spiritual exercises and conversation with God when we are on talking terms.

3. What does it mean to you to be a faithful member of a presbytery? How do you plan to equip the congregation to which you are being called to be a faithful partner in ministry with the presbytery and the denomination?

I have been involved in Louisville, Great Rivers, Eastminster, and Santa Fe Presbyteries in many different ways – as the recording clerk, member of the Congregational Development Committee more than once, member of the Small Church Committee, liaison for three PNCs, director of one of the church camps, member of the nominating committee for the Presbytery Executive, chair of the Congregational Committee involving new church development.

In addition I have always believed that our role as a pastor included community ministry which involved me in starting or rejuvenating or participating in ministerial alliances.

I am willing to serve in whatever capacity the Presbytery deems appropriate.

4. What particular training have you had in Presbyterian polity? How does Presbyterian polity guide you in your dayto-day ministry?

Attended Union Seminary in Richmond with a polity course taught by Mac Turnage. Great course which challenged us to not see the BoO as just a rule book but a frame work around which to build a healthy and engaged community of faith. It sets the parameters around which power and responsibility are to be used. It can be a guide concerning the health, mission, and ministry of the congregation is measured. It is not a stick to be used to abuse the congregation and leadership.

5. What does it mean to you to be guided by the confessions of the Presbyterian Church (USA)?

I see them as windows into the heart and soul of history and the church through the ages. They can provide us with some wisdom and direction from the past that will need thoughtful consideration and translation, but should never be confused with Scripture.

6. What is your understanding of the significance of the Lord's Supper and Baptism in the Presbyterian Church (USA)?

This would take a book to explain. I hold them in highest regard.

Baptism of a child is a commitment of 3 parties – parents, congregation/larger community of faith, and God – to provide the spiritual, psychological, social, and intellectual support for the child and the parents. It is not simply an act of one congregation, but the act of the people of God as it is an adopting of the child into the community of faith. We are to raise this child as one of our own.

For an adult baptism is an affirmation of faith and a commitment to service in the Kingdom of God as it intersects with the world around us. It is also a commitment on the part of the congregation to provide this person with all the support they need to grow in faith.

Communion is that door into the very presence of God in Jesus, the Christ. We remember, we gain spiritual nourishment, we are bound together with those of the faith. It is open to all who have been baptized into the faith from whatever tradition.

6. What are your interests or special talents which might enrich the Presbytery of Southeastern Illinois?

Let's see St. Louis Cardinals, SciFi, some carpentry skills learned from my time working on HfH, setting up work camps, plumbing learned from growing up in a plumbing shop, some theological knowledge, some counseling skills.

8. Having asked you a lot of questions, is there anything else you would like to ask or share to help us to get to know you better? Do you have any questions or concerns for us?

**The Presbytery of Southeastern Illinois Rossville Administrative Commission Report** November 16, 2017 First Presbyterian Church, Monticello, Illinois

#### **RECOMMENDATION A**

The Rossville Administrative Commission (AC) recommends that the Rossville church and manse property be sold to Robert Danner with a contribution of \$17,000 to be provided by the Presbytery at closing. Danner plans to demolish both properties and provide some retail office pace for the city of Rossville. The AC requires that the following contingencies by accepted by the buyer.

1. Agreement is contingent on approval of the Presbytery of Southeastern Illinois at its November 16, 2017 meeting.

2. The Presbytery will provide due diligence in terminating the tenant from the house before November 31, 2017.

3. Closing to be in the December 1 - 15, 2017 timeframe.

4. Seller out-of-pocket at closing will \$17,000 to the buyer. Seller closing costs will be covered as well.

5. The church and house are sold in "as in condition," which may or may not include items left behind by the tenant in the house.

#### **RECOMMENDATION B**

#### **Rossville Administrative Commission:**

### **RECOMMENDATION C**

All official church record books (rolls & registers and session records) will be given to the Presbytery for permanent storage at the Presbyterian Historical Society. The names of those on the membership roll of the Rossville Church (13 members) will be provided to the Presbytery where their membership will be retained until they request transfer to another congregation.
